and other health care nonprofits. Free mammograms are offered regularly onsite via a mobile mammography unit.

Patients pay between \$20 and \$55 based on their income and number of dependents. Patient fees cover only a small portion of our yearly budget; the balance is provided by grants and private donations from caring individuals, foundations, churches and businesses.

To be eligible for treatment, individuals must be either working at least 20 hours per week, be dependent on a family member who works, be receiving unemployment benefits, or be a full-time student; and either has no health insurance, or who is now insured, but cannot afford the co-pay, coinsurance and/or deductible expenses.

During 2017, Faith Family Medical Center provided care to approximately 2,900 patients - over 896 of these were new patients. The number of approximate visits to each part of our program was 6,638 medical visits and 330 counseling sessions and 1,519 wellness education encounters for a grand total of 9,025. Faith Family also facilitated nearly 1,491 referral appointments for diagnostic testing or specialty consultations.

In addition to the Center's staff, 51 volunteers provided us with 1,843 hours of donated services. These hours included: 8 physicians, 17 nurses, 23 administrative, 1 emergency technician, 1 student/first responder, and 1 physical therapist.

The Center's Journey to Health program is an integrated, multidisciplinary approach designed to help our patients with chronic diseases. This program is offered to equip patients with the knowledge and resources to live a
